- Goal of 100% dedicated lanes
- Parallel to existing local bus route 83
- Combined the community's preferred design features into one alternative – Center-Running BRT
  - Improved travel time
  - Wider sidewalks
  - Increased access/safety
  - Premium amenities



#### **Performance**

- 46% of the individual prime consultants are meeting or exceeding the assigned DBE goal.
  - Chasm Architecture DBE Prime
  - Autaco DBE Prime
  - HNTB currently at 79% (Infrastructure Systems Engineering)
- 23% not meeting goals: in acceptable ranges
  - Within 4% of goal
  - Fluctuations due to timing
  - Shouldn't have problems making up the difference
- 31% not meeting goals: not in acceptable ranges
  - These are the contracts that we are working closely with for compliance
  - There were changes in scope of work that affected DBE percentages
  - Most have plans in place for upcoming tasks



## **Deficiency Actions**

- Automatically send deficiency notices
- Require primes to provide reasons why goal is not being met
- Require a corrective action plan

- Re-emphasizing the importance of DBE participation
- Inclusion Matters & DBE Roundtable series
- Semi-annual reporting to MARTA Board



## Scope of Work during Suspension of Rail Service


- Perform pre-installation checks and surveys.
- Swing, set, and secure bridge.
- Perform post-installation checks and surveys.





## Why is Suspension of Rail Service required?


- The work cannot be performed during operational time without creating a safety impact on passengers. The crane will swing a section of the bridge over the trackway.
- The type of work requires restriction of both tracks.





## **Proposed Work Plan**

- Kensington will become the Blue Line-"End of Line Station". Trains will stop at Kensington and return westbound servicing H.E Holmes.
- Bus Operations will provide a bus bridge from Indian Creek to Kensington.
- Patrons will be encouraged to park at Kensington. However, the parking lot at Indian Creek will remain open.






## Work Schedule for Indian Creek Pedestrian Bridge

Operations Impact	Work Location	Time Period
Prerequisite Work	North property of the station. CMAR will drive piles, set footings, and assemble the bridge in the cleared lot. Crane will arrive, position on site, and prepare for lift.	July 29, 2024 - Dec. 7, 2024
Day 1	Tracks will be placed out of service starting at 2 AM. Final pre-check inspections will take place during daylight hours. Once clear, the crane will pick up the bridge and set it in place. During pick, engineers and steel inspection staff will be on-site for observation and testing. During night hours, CMAR will secure the site.	Starting 2:00 AM Sunday — Dec. 8, 2024
Day 2	The next morning, CMAR and the Testing agency will continue to perform Testing and final inspections. Any findings will be noted and addressed before tracks are put back into service.	Monday, Dec. 9, 2024
Return to Service	Tracks return to revenue service	4:00 AM Tuesday - Dec. 10, 2024



## **Bus Bridge to/from Kensington Station**


- Begins Sunday, Dec. 8, at 4 a.m.

## **Public Messaging Campaign**

- MARTA is renovating Indian Creek Station as part of its State of Good Repair program.
- The new pedestrian bridge will allow more customers on the north side of the station to safely reach MARTA service. Potential for new riders.
- There will also be extensive upgrades to the platform, concourse, walls, furniture, elevator, lighting, public artwork, landscaping, as well as deep cleaning.
- The timeline for opening the new bridge is April 2025. The overall project is scheduled for completion by Spring 2025.



# MARTA Summerhill BRT – RAPID A Line

**AT&T Utility Relocation Agreement**

## **Purpose**

In order to support the prime contractor in the completion of the Summerhill Rapid BRT, AT&T will relocate poles and infrastructure along the project alignment to accommodate roadway widening. This roadway widening is required to meet the lane width standards for the dedicated bus lanes and general-purpose lanes within the project alignment.





## **Project Scope**

- Remove and replace AT&T owned poles and associated guying at 15 locations along the alignment.
- Transfer existing aerial facilities off poles being replaced by Georgia Power to their proposed poles at 3 locations.
- Relocate underground facilities including placement of split duct and shifting existing buried copper cables to their associated poles.
- After road paving, adjust all 84 AT&T manhole lids within the project limits to grade.
